A discussion on the decision by the bureau takes place in the assembly.

There is a point of order to postpone the meeting for 30 minutes.

Proposal: Ivorians their participation fees are waved for this GA in Côte d'Ivoire. As this is a precedent, the next organisation that will organise the GA will not have to pay participation fees.

Proposal: the payment of participation fees for this GA will be extended by two months.

Decision: for the coming GA in Abidjan all organisations, also the ones that have not paid their fees yet, will be able to have their voting rights.

Thus, all organisations with no good standing DO have voting rights this GA in Abidjan.

Young Liberals: What was the advice for the Executive Director hiring process mentioned in the AC report the bureau didn't accept?

Answer: The bureau wanted to make it quite quickly. The AC had some expectations for the timeline.

Young Liberals: The report mentions that the potential on the workload the AC could bring wasn't fully realized. What are the recommendations?

Answer: Hard to understand due to translation simultaneously and the WIFI connection.

YDA: Is it advisable that the AC contributes to the team building of the new board?

Answer: Yes, we can see to what extent it is appropriate that we can help.

JuLis: Share of work. Elaborate what problems the AC detected there

Answer: Developed in different directions.

Bureau reports:

Q Jonge Democraten to Sam and Bram: Are you aware, that the terms of both end in est. November 2025?

A by Bram: We are aware of the constraint the mandate gives us.

Q Jonge Democraten to Sam and Bram: What happened with the questionable payment to a Bureau member that is mentioned in the AC report?

A by Sam: Do not agree, because the subsequence is partly wrong about how the bureau works. The payment in question was a payment made within a project of a donor. Such payments have been made more often in the past to Bureau members, but mostly with the consent of the donor. A more transparent process is needed into the transfers, as the process is unclear.

Q by Jonge Democraten to Sam: Do you think that your role as treasurer is still sustainable?

A by Rami and Sam: Rami and Sam have a discussion over the rightfulness of certain statements.

Q by Jonge Democraten to Rami: What would you like to be your lesson to IFLRY?

A by Rami: More diversity of opinions is needed in IFLRY.

Q by Jonge Democraten to Aliona: How does it work with Instagram posts, is information first announced on Instagram instead of in direct communication with the members?

A by Aliona: Yes, we first announced the GA on Instagram as the social media team agreed that it should be announced as soon as possible.

Q by Jonge Democraten to Bram: Is it systematic that the schedules of GA's are announced so late?

A by Bram: No, this was an exception. The coming GA and deadlines will be announced more time in advance.

JuLis question to all Bureau Members: What is the concrete achievement you had in the past year?

A by Rami: Running the study session with Bram.

A by Aliona: Working together with the programme managers of her programmes, namely the Eastern Europe Programme and Female Leadership Academy

A by Bram: Representing this federation on a global stage and stay in contact with partner organizations.

A by Benjamin: The Kenya seminar and other activities in Africa.

A by Abdallah: Project about the fight against antisemitism and islamophobia within IFLRY.

A by Valentine: Able to provide a trilingual interpretation during the last GA. Holding a seminar in Spanish and English. Strengthen liberalism in Latin America.

A by Sam: Identical to Abdallah: Study trip to Israel and Palestine and holding a seminar there.

Q: Why is there no professional translation?

A by Valentine: Good professional translation is very expensive. The translation in Columbia was a lot better, but due to the bad WIFI connection in the current hotel, we could not have proper translation here for some parts. We apologise and will try to work at it for next time.

Q by Julis: How many congresses has the board visited of member organisations?

A by all Bureau Members: Bureau members had different answers but generally seen it was difficult due to financial or visa restrictions.

Q to Valentine: How do you manage the team effectively with deadlines?

A by Valentine: Everyone has different types of responsibilities; one cannot be held accountable for other people's tasks. There are a lot of projects without deadlines, therefore it is easy to postpone.

Q by Jonge Democraten to Rami: Can Rami reflect on the breach of confidentiality in the AC report?

A by Rami: Personal information about me was leaked to members of IFLRY. I am disappointed that there was no support from my Bureau members.

Q by Jonge Democraten to Aliona: What was the decision-making process around the two posts on Instagram regarding Gaza?

A by Aliona: As it was an urgent case, it was discussed by the Bureau and the Bureau decided the posts were fine.

Rami and Abdullah add that the decision was made without them, thus it was a failure of the Bureau.

Sam adds that the discussion is mixed up.

Full membership Egyptian Youth council from Egypt

Q by JD: How can a Youth Council also be considered a liberal organisation in IFLRY?

A by the Egyptian Youth Council: A council in Egypt is the only legal way in society to be a civil organization, so the Council is a legal shape for a liberal organization in this case.

Q by Julis: Is it still the case that the organization is sponsored a lot by the government? And how do you view as organization at Press Freedom Egypt? How can your contribution to IFLRY help to create more awareness on Press Freedom in Egypt?

A by the Egyptian Youth Council: No, we do not receive any funding from the Ministry. We do take a license of the Ministry of Social Solidarity to be operational, but no separate funds. Regarding press, journalists do not get jailed just because they are journalists but due to different reasons. Thus, the question on Press Freedom is not as straightforward as assumed in the question.

Q by Young Liberals: Can you name one or two things as biggest achievements in IFLRY? How often do elections for the Council of Ministers take place?

A by the Egyptian Youth Council: They have improved a lot regarding organization, also every couple of years elections take place for the Council.

Q by JOVD: How are women rights in Egypt and what is your opinion of it?

A by the Egyptian Youth Council: We are working on projects and programmes for female empowerment. While we suffer with issues in the country, we are working hard on taking good steps for more empowerment.

A by Elise: The appropriateness of taxi payments is impossible to determine now due to old and blurred financial policy lines, as appropriateness can only be determined if thresholds or guidelines exist to hold payments against. But now, under the old blurred financial policy lines, the taxi payments are not just. But as these are not representative, we would rather advise to update the financial policy lines than to make conclusions now.

Multiple delegates present an argument in favour or against the motion. Bram Roodhart proposes in his speech that he believes it would be suitable if the members found another solution than using the heaviest tool of no-confidence.


